We hereby submit specifications and estimates for:

We propose to furnish and install (1) Custom Vestibule to abut an existing entrance @ 138 1/2" wide x 95" tall x 7'-1" tall divided into (2) equal bays in width. Each side will have (2) horizontals and there will also be a 4 1/2" square post at each corner to connect all (3) sides. In the main section @ 138 1/2" wide x 84" tall with a pair of doors in the center 6'-0" wide x 84" tall in medium stile rails each with 1 1/2 pair of butt hinges on each leaf, a Standard M-S lock with (1) pair of flush bolts on the inactive leaf and (1) keyed cylinder exterior with a thumb turn interior. Each door will have LCN 4040 closers with drop plates and parallel arms, also an ADA 4" aluminum threshold. All glass will be 1/4" Clear Tempered. Opening is existing.

Total \$16,995.00

Note: When price was given I was told 10'-0" wide, field measured @ 139" wide at 20" wider. This could affect the price a little.
